1. **STUDENT** agrees that prior to participating, he/she will inspect the facilities, equipment and area to be used, and if STUDENT believes any of them unsafe, STUDENT will immediately advise the owner of the studio.
2. **STUDENT** acknowledges that he/she fully understands that his/her participation may involve risk of serious injury or death, including economic losses, which may result not only from his/her own actions, inaction, or negligence, but also from actions, inaction, or negligence of others, the condition of the facilities, equipment, or sport where the event or activity is being conducted.
3. **STUDENT** assumes any and all risks of personal injuries to him/herself, including medical or hospital bills, permanent or partial disability, death, and damage to his/her property caused by or arising from his/her participation in this described art of self-defense.
4. **STUDENT** agrees not to sue or present any claim for personal injury, property damage, or wrongful death against the STUDIO, its agents, servants and employees.
5. **STUDENT** hereby represents that he/she is physically fit to take the prescribed course of instruction and that he/she had an opportunity to observe and participate in the above-described art of self-defense prior to signing this AGREEMENT AND LIABILITY RELEASE WAIVER.
6. **STUDENT** agrees to release, waive, discharge and relinquish STUDIO, its agents, servants and employees from any liability, loss, damage claim, demand or cause of action against them arising from or attributed to his/her participation in the Martial Arts, whether same shall arise by their negligence or otherwise;
